WE, the undersigned, all being of full age, desiring to form a corporation pursuant to Article Two of the Membership Corporation Law of the State of New York, do hereby make, subscribe and acknowledge this certificate for that purpose, as follows:

**FIRST:** The name of the proposed corporation is **South Bay Cruising Club, Inc.**

**SECOND:** The purposes for which it is to be formed are:  
To promote cruising under sail on Great South Bay and nearby waters and the arts of seamanship and navigation in connection therewith.

To do any and all lawful acts and things which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment or attainment of any or all of the purposes of the Corporation.

**THIRD:** The territory in which its operations are principally to be conducted is the waters of the Great South Bay, but its operations shall not be limited to such territory.

**FOURTH:** Its principal office is to be located in the Village and Town of Babylon, County of Suffolk and State of New York.
